

# Toppling of *Roe* Closes Shameful Era, Galvanizes Pro-Life Movement to End Abortion in All 50 States

*Roe v. Wade* is tossed on the ash heap of history; pro-life leaders focus on building a culture where all children are welcomed in life and protected by law

**Rapid City, SD, June 24, 2022**— Camille Pauley, President of Healing the Culture, praised the U.S. Supreme Court’s decision to overturn its previous rulings in *Roe v. Wade* and *Planned Parenthood vs. Casey* which created a *de facto* legal entitlement to abortion nationwide.

“Today’s outcome would have been impossible without the tireless efforts of millions of Americans who fought for the precious lives of innocent preborn children,” said Pauley. “Much will be written in the coming days about the challenges that still lie ahead, but today we savor this triumph over the evil of abortion. We hail the end of a judicial tyranny that for nearly half a century imposed a nationwide regime of merciless abortion-on-demand. We have bent the arc of history and this occasion must be celebrated.”

Pauley noted that all Americans should pause to remember the millions of children whose lives were lost during nearly 50 years of judicially sanctioned murder. “More than 63 million preborn boys and girls have been sacrificed on the altar of greed and selfishness, undergirded by poisonous legal ideologies,” said Pauley. “Let us resolve that these millions of children will not have died in vain. We will keep their memory alive as we press forward to build a society where all children are welcomed in life and protected by law.”

The pro-life movement, according to Pauley, stands to be galvanized and emboldened by the high court’s decision in *Dobbs v. Jackson Women’s Health Organization*. “For decades, the brutal judicial regime created by *Roe* and *Casey* has acted like a legal straitjacket that has constrained our ability to enact life-protecting laws,” Pauley noted. “Now liberated from these barbaric judicial roadblocks, we can and will move forward quickly with both state- and federal-level initiatives to protect all children from the violence of abortion.”

Pauley observed that in many states, the enactment of life-protecting laws will occur only after cultural attitudes on abortion have undergone significant evolution. “Healing the Culture plans to deploy its educational programs in the most abortion-vulnerable states, utilizing a variety of creative media, and collaborating with organizations and institutions across the country. A new day has dawned. Tomorrow we roll up our sleeves and get back to work.”
